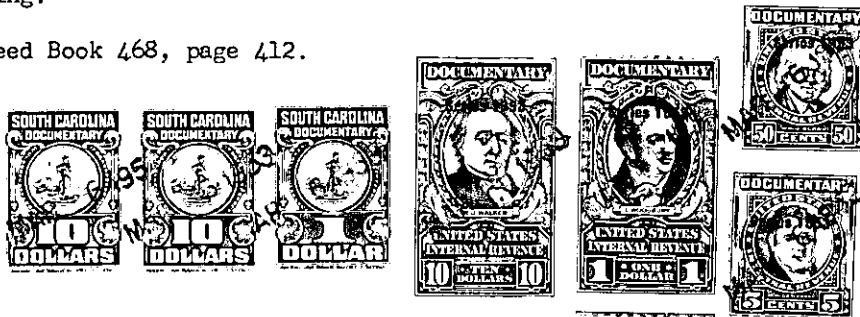
John Bruce Linville, his heirs and assigns, forever:
