Know All Men by These Presents:

That I, Adolphus Lee, in the State aforesaid, in consideration of the sum of Seven Hundred and Fifty (\$750.00) DOLLARS, Total Consideration for two deeds

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. P. Lee, his heirs and assigns forever, all my right, title, and interest in and to the following described real estate:

On tract of land containing 102 1/2 acres as shown on copy of a plat made by Mr. Fuller, Surveyor, in 1884, said copy being made by W. A. Hester, February 18, 1938, and being more particularly described according to said plat, as follows:

BEGINNING at a stake in bridge crossing Beaverdam Creek, corner of land of H. B. Lee, and running thence N. 48- 3/4 E. 26.20 chains to pine 3X; thence 56 E. 5.60 chains to water oak (dead) thence N. 76 1/2 E. 880 chains to a Chestnut O. M.; thence S. 55 #. 19.10 chains to a point on Beaverdam Creek; thence S. 39 W. 1.50 chains to the mouth of a branch; thence along the middle of the branch to a spring; thence S. 18 W., crossing the road, 3.70 chains to a sweetgum; thence S. 39 E. 10.20 chains to a poplar; thence S. 43- 3/4 W., crossing branch, 28.00 chains to a post oak; thence N. 87 W. 16.50 chains to a stake; thence N. 15 E. 5.00 chains to blackgum; thence N. 39 W. 10.80 chains to a water oak; thence N. 89 E. 3.90 chains to chestnut thence N. 66 E 9.30 chains to a sourwood xom; thence due North 8.50 chains to a chestnut stump on the side of the road; thence with the road, N. 79 E. 9.00 chains to a stone in branch thence with the branch in northerly direction 2.00 chains to the mouth of the branch in Beaverdam Creek; thence up the creek to the stake at the bridge, the beginning corner.
