to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Thomas D. Christopher, his heirs and assigns, forever:

All that lot of land situate on the northwest side of Scarlett Street (formerly known as Forest Green Road), in the City of Greenville, in Greenville County, S.C., being shown as Lot No. 233 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, revised through November 1952, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", at Pages 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Scarlett Street, at joint front corner of Lots 232 and 233 and running thence with the line of Lot 232, N. 76-44 W. 175 feet to an iron pin; thence N. 13-16 E. 75 feet to an iron pin; thence with the line of Lot 234, S. 76-44 E. 175 feet to an iron pin on the northwest side of Scarlett Street; thence along the northwest side of Scarlett Street, S. 13-16 W. 75 feet to the beginning corner.
