in consideration of the sum of Eight Hundred Fifty (\$850.00) - DOLLARS,

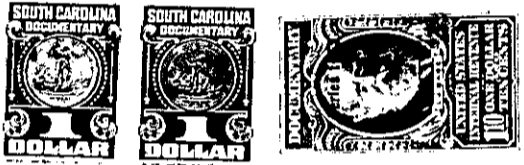

All that certain lot of land in Paris Mountain Township, Greenville County, state of South Carolina, being known and designated as lot No. 71, Map No. 2 of Sans Souci Heights, as shown on plat thereof recorded in the R. L. C. Office for Greenville County in Plat book Z page 53 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeast corner of the intersection of Merrilat Avenue and Callahan Avenue, and running thence with the north side of Merrilat Avenue S. 77-38 E. 75 feet to an iron pin, corner of lot No. 72; thence with the line of said lot N. 11-42 E. 39.2 feet to an iron pin corner of lot No. 70; thence with the line of said lot S. 77-38 W. 75 feet to an iron pin on the east side of Callahan Avenue; thence with the east side of said street S. 11-34 W. 39.2 feet to the beginning corner.
