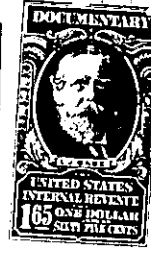

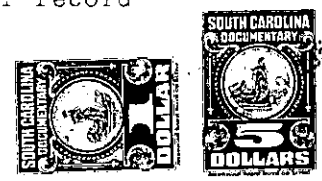

BEGINNING at a point on the North side of Sunset Drive at the joint front corner of Lots 23 and 24 and running thence N. 25-29 E. 179.2 feet along the line of Lot No. 23 to the rear corner thereof on line of Lot No. 13, thence N. 48-57 W. 40.8 feet along line of Lot No. 13 to joint rear corner of Lots 24 and 25, thence S. 48-29 E. 197.7 feet along line of Lot No. 25 to a point on Sunset Drive, thence S. 53-04 E. 39.7 feet along Sunset Drive to a point, thence S. 64-31 E. 78 feet continuing along Sunset Drive to the beginning corner, being a part of the same property deeded to us by Julia M. Jenkinson, et al., by their deed dated September 6, 1948, and recorded in the R. M. C. Office for Greenville County in Deed Book 358, page 213.
