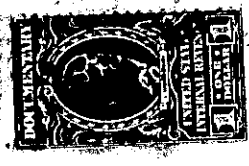

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Hugh Walter Sparks, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southwesterly side of Westbrook Lane, near the City of Greenville, S. C., being shown as Lot No. 9, Block "C", on the plat of Brookforest as recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 41, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Westbrook Lane at a point 455.5 feet Northwest of the Westerly corner of the intersection of Westbrook Lane and Woodmont Circle, said pin being the joint front corner of Lots Nos. 8 and 9, Block "C", and running thence along the Southwesterly side of Westbrook Lane N 34-18 W 70 feet to an iron pin, joint front corner of Lots Nos. 9 and 10; thence along the joint line of said Lots S 55-42 W 175 feet to an iron pin, joint corner with Lot No. 23; thence along the joint line with Lot No. 23 S 34-18 E 70 feet to an iron pin, joint rear corner of Lots Nos. 8 and 9; thence along the joint line of Lots Nos. 8 and 9 N 55-42 E 175 feet to the point of beginning.

This is one of the lots conveyed to the grantor by the deed recorded in Deed Book 503, page 438.
