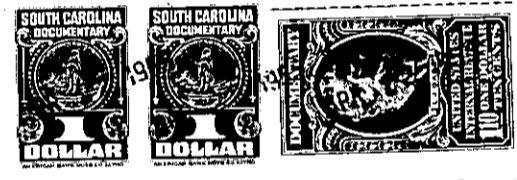
LES E. DELLINGER, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 155, Section III, Lake Forest Subdivision, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG" page 77, and having, according to said plat, the following metes and bounds, to-wit: *L.P. d.w.c.*

BEGINNING at an iron pin on the Northerly side of Rockmont Road, joint front corner Lots 154 and 155, and running thence N. 36-41 E. 321.1 feet to a branch; thence with the branch as the line and with the high water mark of Lake Fairfield as the line, the traverse line being N. 70-06 W. 100 feet to a point in the dam of Lake Fairfield and continuing with the traverse line N. 69-27 W. 175.7 feet to a point, at which the common line of Lots 155 and 156 join at the highwater mark of Lake Fairfield; thence along the common line of Lots 155 and 156 S. 24-23 W. 248.1 feet to an iron pin on the Northerly side of Rockmont Road, joint front corner Lots 155 and 156; thence along the Northerly side of Rockmont Road S. 56-05 E. 115.4 feet to a point; thence continuing along the Northerly side of Rockmont Road S. 49- 26 E. 96.6 feet to an iron pin, the point of beginning.
