All that lot of land in the City and County of Greenville, State of South Carolina being known as lot no. 1 on plat of Pleasant View by C. C. Jones dated February, 1954 recorded in the R.M.C. Office for Greenville County in Plat Book HH at Page 52 and having according to said plat the following metes and bounds, to-wit:
