CORRECTION DEED

KNOW ALL MEN BY THESE PRESENTS That

I, WILLIAM B. DUCKER,

in the State aforesaid,

in consideration of the sum of Ten and No/100ths ----- Dollars,
(\$10.00)-----
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto COLE B. KEENAN:

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Western side of Darlington Avenue, being known and designated as Lot No. 5 as shown on a plat prepared by Dalton & Neves, dated December, 1954, entitled "Property of William B. Ducker," recorded in the R. M. C. Office for Greenville County in Plat Book HH at page 201, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING AT an iron pin at the intersection of Darlington Avenue and a 14-foot street and running thence N. 41-37 W. 98.2 feet to an iron pin; thence N. 4-32 E. 52.6 feet to an iron pin, joint rear corner of Lots 4 and 5; thence along the line of Lot 4 S. 60-21 E. 115.1 feet to an iron pin on the Western side of Darlington Avenue; thence along the Western side of Darlington Avenue S. 29-39 W. 80.1 feet to the point of beginning.

This is a portion of the property conveyed to William B. Ducker by O. O. Freeman by his deed dated November 12, 1954, and recorded in the R. M. C. Office for Greenville County in Deed Book 512 at page 91.

This deed is given for the purpose of correcting a description in a deed from the grantor to the grantee, dated February 16, 1955, recorded in the R. M. C. Office for Greenville County in Deed Book 522 at page 223, conveying the same lot hereinabove referred to, but erroneously describing said lot according to a plat recorded in the R. M. C. Office for Greenville County in Plat Book HH at page 130, rather than the plat hereinabove referred to.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
