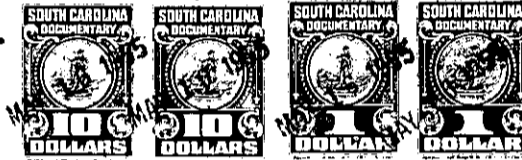
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sarah L. Hingson, and her heirs and assigns,

ALL of that piece, parcel or lot of land situate, lying and being in the County of Greenville, South Carolina, Austin Township, about six (6) miles from the City of Greenville and about one (1) mile North of the town of Mauldin, located just West of the Greenville-Laurens Highway, known as Tract No. 1 of the property of Dorothy Daves Howard, as shown on plat of said property made by W. J. Riddle, surveyor, June, 1947, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book Q at Page 113 and containing 2.12 acres, more or less, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of property now or formerly of Dorothy Daves Howard and the property now or formerly owned by A. B. Forrester, and running thence N 46-15 W 408 feet to an iron pin; thence S 43-30 W 263.8 feet to a stake; thence S 51-20 E 409 feet to an iron pin; thence N 44-15 E 227 feet to an iron pin at the beginning corner.

This being the same property conveyed to the grantor herein by deed of Allen D. Howland, et al, dated January 29, 1951 and recorded in the R. M. C. Office for Greenville County, South Carolina in Deeds Book 429 at Page 11.

The grantee herein agrees to pay the taxes for 1955.
