to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), Hubert E. Thomas, his heirs and assigns forever;

All those pieces, parcels, or lots of land situate, lying and being in the State of South Carolina, County of Greenville, at the intersection of Grove Road and a 36-foot road, and being known and designated as Lots Nos. 1 and 2 of the property of T. T. Thomas and Jennie E. Thomas as shown on a plat thereof prepared by C. C. Jones and Associates, Engineers, May 24, 1955, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern intersection of a 36-foot road and Grove Road, and running thence with said 36-foot road, S. 87-52 W. 210 feet to an iron pin at the joint front corner of Lots 2 and 3; thence with the joint line of said lots, N. 2-08 W. 150 feet to an iron pin; thence N. 87-52 E. 231.8 feet to an iron pin on the western side of Grove Road; thence with said road, S. 6-07 W. 151.4 feet to the beginning corner.
