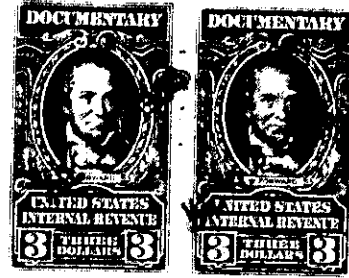
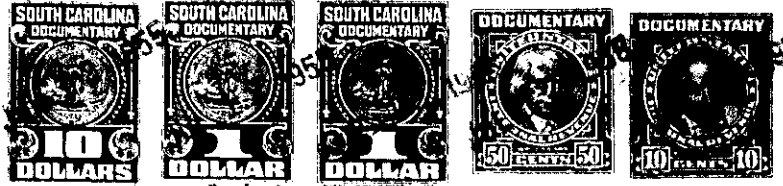

presents do grant, bargain, sell and release unto the said Raymond H. Canady, John L. Goggin, Cornelia Mellichamp, Jessie F. Wood and Ruth P. Caine, as Directors of First Church of Christ, Scientist, Greenville, S. C.,

all that piece, parcel or lot of land in

Township, Greenville

County, State of South Carolina, on the east side of Southland Avenue and the west side of Boxwood Lane, being more particularly shown on plat of property of E. D. Sloan dated June, 1955, prepared by R. E. Dalton, Engineer, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the east side of Southland Avenue and running thence N. 26-10 W. 266 feet to an iron pin; thence turning and running N. 63-50 E. 127 feet to an iron pin; thence turning and running S. 76-13 E. 127.4 feet to an iron pin on the west side of Boxwood Lane; thence along the west side of Boxwood Lane S. 13-47 W. 266 feet to an iron pin; thence turning a curve, the chord of which is S. 83-48 W. 57.5 feet, to the beginning point; containing 1.00 acres, more or less.

This deed of conveyance is made upon condition that the said Directors and their successors in office shall hold and enjoy the said premises for the sole use and benefit of First Church of Christ, Scientist, Greenville, S. C., an unincorporated religious society.

Grantor agrees to grade and surface Boxwood Lane and agrees that adequate water and sewerage facilities will be available to the grantees within six months from the date hereof.
