ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, in Greenville Township, being known and designated as LOT NO. 19 on BIRCHWOOD DRIVE as shown on plat of Subdivision known as Kirkwood Heights according to Survey made by Pickell & Pickell, Engrs. in October 1954 and recorded in the RMC Office for Greenville County in Plat Book "EE", at pages 110 and 111 and having the following metes and bounds, to wit:
