Know All Men by These Presents:

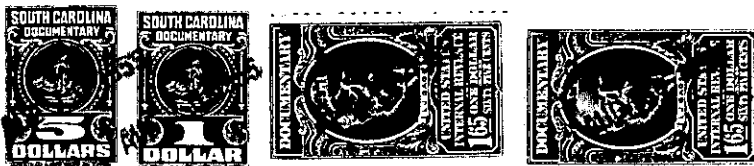

Dempsey in the State aforesaid, in consideration of the sum of Two Thousand Five Hundred and No/100----- DOLLARS, and the exchange of property valued at \$500.00 to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

C. Paul Manly, his heirs and assigns forever:

All that certain piece, parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina about four miles west of Greer, South Carolina containing 9.38 acres, more or less, and being known and designated as Tracts Nos. 1 and 2 of Property of A. F. Alexander as shown on plat thereof by H. S. Brockman, Engineer dated September 2, 1952 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the northern side of the Enoree River and running thence N. 22-45 E. 1333 feet to a stake in the forks of a branch; thence N. 45-30 W. 52.5 feet to an iron pin; thence S. 52-48 W. 441 feet to an iron pin; S. 80-10 W. 152 feet to an iron pin; thence S. 26-25 W. 163 feet to an iron pin; thence S. 32-37 W. 200 feet to an iron pin; thence S. 43-33 E. 72.6 feet to a stake in the mouth of a ditch; thence S. 4-50 E. 72 feet; thence S. 30-05 W. 136 feet; thence S. 0-30 W. 340 feet to mouth of branch on Enoree River; thence along the northern side of the Enoree River (the chord of which is S. 70-25 E.) 231 feet to the beginning corner.

The above described property is the same conveyed to me by A. F. Alexander by his deed dated October 7, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Book 509, page 463.
