to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ANCROM YOUNG, his Heirs and Assigns,

ALL that certain parcel or tract of land in Grove Township, County of Greenville, State of South Carolina containing 3.44 Acres, more or less and being designated as Tract No. 7 as shown on the plat of the property of L. W. Young, dated April, 1955, by C. O. Riddle, Registered Surveyor as recorded in Plat Book No. II Page 119 Office of the R. M. C. for Greenville County, the said tract being more particularly described by metes and bounds as follows:

BEGINNING at an iron pin at joint corner of Tracts 6 and 7, and running N. 35-00", 340 Feet to an iron pin at common corner of Tracts 7 and 8; thence N. 52-28 E., 412.9 Feet to an iron pin at the common corner of Tracts 7 and 8; Thence S. 40-04 E., 340 Feet to an iron pin at the common corner of Tracts six and seven; Thence S. 52-28 E., 443 Feet along the common line of Tracts 6 and 7 to the point of Beginning.

BEING a part of the property conveyed to the Grantor L. W. Young by E. Inman, Master on October 20, 1923 as noted in Deed Book I Page 81, Office of the R. M. C. for Greenville County.
