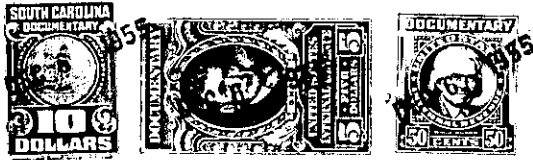
J. H. Sitton, his heirs and assigns forever:
