in consideration of the sum of Two Hundred Ten and No/100 (\$210.00) in the State aforesaid, -DOLLARS,

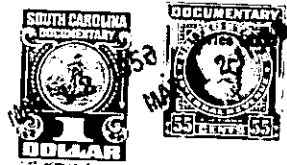
