That I, H. M. FERGUSON, in the State aforesaid, in consideration of the sum of Three hundred Sixty-six (\$366.00) --- DOLLARS,

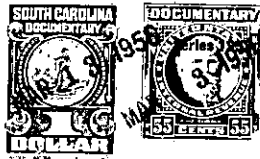
