in consideration of the sum of Four Hundred Thirty-five and 60/100----- in the State aforesaid, DOLLARS,

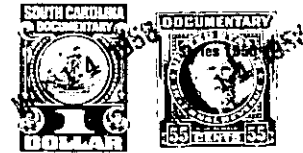
