in consideration of the sum of Two Hundred Twenty Nine and No/100----- in the State aforesaid, DOLLARS,

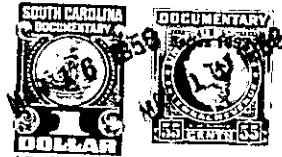
