in consideration of the sum of Six Hundred Forty Three and 50/100 - - - - - in the State aforesaid, DOLLARS,

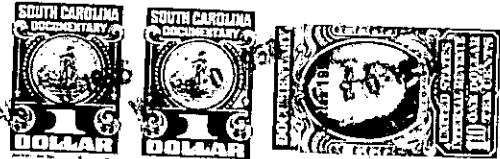
