Know All Men by These Presents:

That I, Henry P. Willimon in the State aforesaid, in consideration of the sum of Two Hundred Ninety-five and 00/100-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Richard P. Norris and Edna Norris, their heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as lot no. 153 of Pine Forest as shown by a plat thereof made by Madison H. Woodward, Engineer, said lot having the following courses, distances, metes and bounds, to wit:

BEGINNING, at an iron pin on Charles Drive joint front corners of lots 152 and 153 and running thence S. 89-31 E. 150 feet to an iron pin joint rear corners of lots 152, 176, 175 and 153; thence along the line of lots 153 and 175 N. 0-29 E. 60 feet to an iron pin joint rear corners of lots 174, 175, 154 and 153; thence along the line of lots 154 and 153 N. 89-31 W. 150 feet to an iron pin joint front corners of lots 154 and 153; thence along Charles Drive S. 0-29 W. 60 feet to an iron pin, the point of beginning.

That the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence to cost less than Two Thousand(\$2000.00) Dollars, shall be erected on said lot, and no residence shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty-(50) feet or more frontage.

GRANTEE to pay taxes for the year 1956.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
