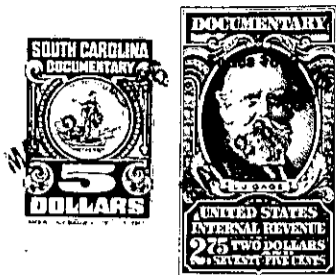

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ROY A. PEACE, his heirs and assigns, forever:

ALL that lot of land, situate on the West side of Stratford Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 114 on Plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "GG", page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Stratford Road at joint front corner of Lots 113 and 114 and running thence along the line of Lot 113 S. 80-33 W. 139.6 feet to an iron pin; thence S. 5-20 E. 98.9 feet to an iron pin; thence with the line of Lot 115 N. 71-44 E. 150 feet to an iron pin on the West side of Stratford Road; thence with Stratford Road N. 14-02 W. 15.5 feet to an iron pin; thence continuing with Stratford Road N. 9-27 W. 80 feet to the beginning corner.

ALSO all that lot of land, situate on the West side of Stratford Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 116 on Plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "GG", page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Stratford Road at joint front corner of Lots 115 and 116 and running thence with the line of Lot 115 S. 71-44 W. 155.1 feet to an iron pin; thence S. 14-45 E. 80.2 feet to an iron pin; thence with the line of Lot 117 N. 71-44 E. 160 feet to an iron pin on the West side of Stratford Road; thence with the West side of Stratford Road N. 18-16 W. 80 feet to the beginning corner.

This property is conveyed subject to the restrictions applicable to South Forest Estates, which are recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 547, at Page 66.

The above property is a portion of the tracts of land lying South of Fairfield Road which were conveyed to the Grantors by Deed of Eula Croft Valentine, dated January 1, 1955, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 517, page 138, and by deed of Albert L. Taylor, dated November 9, 1954, recorded in the R.M.C. Office for Greenville County, S.
