Know All Men by These Presents:

That I, Walter W. Goldsmith, in the State aforesaid,
in consideration of the sum of Five Hundred Sixty and 00/100----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s). (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. R. Hill and Beulah Hill, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot no. 30 of Section "C", of a subdivision known as Englewood Estates, as shown by a plat thereof dated December, 1951, recorded in R. M. C. Office for Greenville County, in Plat Book "BB", at page 13, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on Shasta Drive, joint front corner of lots 30 and 31 and running thence N. 87-30 W. 70 feet to an iron pin, joint front corner of lots 30 and 29; thence along the line of lots 30 and 29 N. 2-30 E. 175 feet to an iron pin in the southwest line of lot 175; thence along the line of lots 175 and 30 S. 87-30 E. 70 feet to an iron pin in the southwest line of lot 175 and joint rear corner of lots 30 and 31; thence along the line of lots 30 and 31 S. 2-30 W. 175 feet to an iron pin on Shasta Drive, the point of beginning.

Restrictions:

That said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence is to cost less than Eight Thousand Five Hundred (\$8500.00) Dollars; no residence shall be erected on said lot nearer than fifty(50) feet to the front line; no residence shall be built on any lot unless said lot has fifty(50) feet or more frontage; no outside toilets are permitted and sewage is to be disposed of by approved septic tank.

GRANTEE is to pay taxes for the year 1956.

THIS DEED is conveyed subject to any rights-of-way now existing.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
