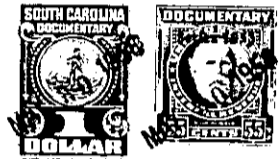

W. Lewis Stover, his heirs and assigns, forever

All that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, to the rear of Lot No. 23 of Section I of Lake Forest, as shown on plat entitled "Property of E. D. Cobb", made by C. O. Riddle, Reg. L. S., Mary 1956, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point in the old line of the grantor and grantee, which point is 67 feet N. 28-24 W. from an iron pin in the North side of Stonewall Lance, and running thence N. 28-24 W. 102.4 feet to an iron pin; thence S. 79-33 W. 45 feet; thence S. 15-33 W. 55 feet; thence S. 74-25 E. 75 feet to an iron pin; thence S. 76-18 E. 36.5 feet to the point of beginning.

This lot of land is conveyed to the grantee subject to the same restrictions applicable to Lot No. 23 of Lake Forest, the protective covenants applicable to which are recorded in Deed Book 485, at page 373 and which are made a part of this conveyance.
