Know All Men by These Presents:

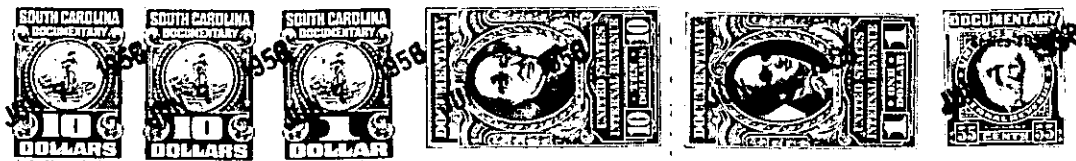
That I, Alline O. Cannon in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hugh K. Robertson and Lou Nell S. Robertson,

All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as Lot No. 17, on plat of Pine Brook Development recorded in plat book Z page 148 of the R.M. C. Office for Greenville County, and having according to a more recent survey made by R. W. Dalton, May 1956 the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the northeast side of Elaine Avenue (Formerly Keasler Street), the front joint corner of Lots Nos. 17 & 19; thence with the joint line of said lots N. 56-29 E. 150 feet to an iron pin corner of lot No. 58; thence with the line of said lot S. 33-31 E. 75 feet to an iron pin corner of lot No. 15; thence with the line of said lot S. 56-29 W. 150 feet to an iron pin on the north side of Elaine Avenue; thence with the northeast side of said Elaine Avenue N. 33-31 W. 75 feet to the beginning corner.
