Grantor Mary Parr Winte received this property in the name of Mary Parr and has subsequently remarried and is now Mary Parr Winte.

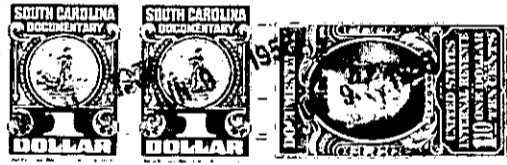
