KNOW ALL MEN BY THESE PRESENTS, That We, Robert A. Daniel and wife, Nancy Daniel

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. Raymond Howe, Jr. and wife, Mrs. C. Raymond Howe, Jr., their heirs and assigns, forever:

~~County, State of South Carolina~~

All those certain two lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 19 and 20 of Block C as shown on Plat of Buena Vista as recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book 7 at page 11 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Sutton Drive at the joint front corner of Lots Nos. 20 and 21, and running thence with the line of Lot No. 21, N. 80-17 E. 150 feet to an iron pin; thence N. 9-42 W. 70 feet to an iron pin, corner of Lot No. 18; thence with the line of Lot No. 18, S. 80-17 W. 150 feet to an iron pin on Sutton Drive; thence with the Eastern side of Sutton Drive, S. 9-42 E. 70 feet to the point of beginning.
