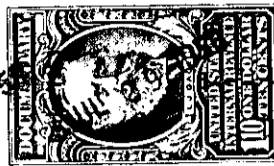

I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Bessie Q. Wood, in her own right and as Administratrix of the
Estate of I. M. Wood, deceased, Plaintiff

on or about the 7th day of July in the year of
our Lord nineteen hundred and Fifty Six exhibited her
complaint in the Court of Common Pleas, for the County aforesaid, against T. J. Wood,
Pearl W. James, et al, Defendants

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the 12th day of November 1955,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree, upon receipt of \$750.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Charles Brannon and Navis Brannon

All that certain lot of land situated in Chicks Springs Township,
County and State aforesaid, being known and designated as lot No. 50 in
what is known as Woodland Heights, property of the I. M. Wood Estate as
shown on a subdivision and plat of same made by N. S. Brodman, Lic.
Surveyor, dated October 28, 1955, said plat being of record in the
R. M. C. Office for Greenville County in Plat Book 66, page 151 and
having the following notes and bounds and courses and distances as shown
by said plat, to-wit:

BEGINNING at an iron pin in the Northern boundary of Bessie Avenue,
joint front corner of lots 56 and 57, and running thence along the
Northern line of Bessie Avenue N. 45-18 E. 100 feet to an iron pin at
corner of lot No. 55; thence along the Western boundary of this lot
N. 38-52 W. 211.2 feet to an iron pin; thence S. 30-12 W. 191 feet to an
iron pin at corner of lot No. 57; thence along the Eastern boundary of
this lot S. 58-43 E. 200.5 feet to the remaining point in the Northern
line of Bessie Avenue.
