in consideration of the sum of Four Hundred Twenty-three and 50/100---(\$423.50) in the State aforesaid,

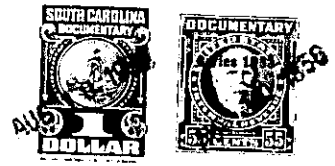
