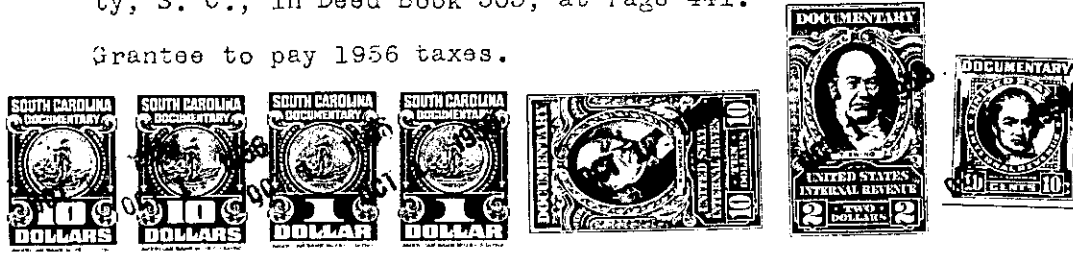
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said CECILE G. PARRISH, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the west side of Underwood Avenue, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 49 on plat of Glenn Grove Park, made by R. E. Dalton, Engineer, May, 1924, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "F", at Page 233, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of Underwood Avenue, at joint front corner of Lots 48 and 49, and running thence with the line of Lot 48, N 74-12 W, 150 feet to an iron pin; thence N 15-48 E, 50 feet to an iron pin; thence with the line of Lot 50, S 74-12 E, 150 feet to an iron pin on the west side of Underwood Avenue; thence with Underwood Avenue, S 15-48 W, 50 feet to the beginning corner.
