That I, R. Hugh Vernon in the State aforesaid,  
in consideration of the sum of Nine hundred twenty five (\$925.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Homer Styles, his heirs and assigns,

All that parcel of land in Bates Township, Greenville County, State of South Carolina, located about three miles north of Travelers Rest, S.C. on Western side of U.S. highway No. 276, the same being shown and designated as Lots 57 and 58 on a Plat of the property of the "Nannie K. Hunt Estate", plat made by H.L. Lunahbo, surveyor, dated Nov. 15 and 16, 1951, and recorded in Plat Book AA, Page 134, R.M.C. Office for Greenville County and having according to said plat the following courses and distances, to wit:

BEGINNING at a point on a newly cut 36 foot street (now tar and gravel), joint corner of lots 56 and 57 on said plat, and running thence along said newly cut street S. 26-15 E. 210 feet to a point at the edge of north western corner of the intersection of said newly cut street and a tar and gravel county road; thence along the northern edge of said tar and gravel county road, S 85-25 W 213 feet to a point, joint corner of lots 58 and 59; thence N 26-15 W 136 feet to a point, joint corner of lots 56 and 57; thence N 63-30 E 200 feet to a point on the western edge of said newly cut street, the beginning corner.

Being the same property conveyed to grantor by Josephine and Ernest C. Vernon, by deed dated October 20th, 1954 and recorded in R.M.C. Office Greenville County, in Volume 510 at page 381.
