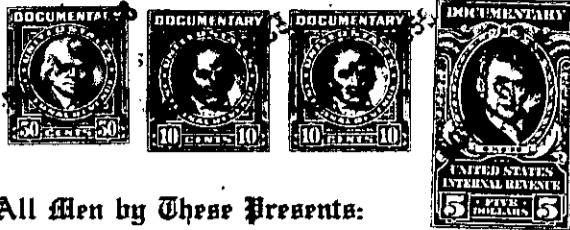


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY



Know All Men by These Presents:

That I, DONALD E. BALTZ in the State aforesaid, in consideration of the sum of Seven Thousand (\$7,000.00) DOLLARS, and subject to mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HARLEY PAT ROBERTS,

All that lot of land in the county of Greenville, state of South Carolina, designated as Lot No. 19, Block D, on plat of Brookforest, recorded in plat book BB page 41 of the R. M. C. Office for Greenville County and having according to the said plat and a recent survey made October 1956 by R. W. Dalton, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Woodmont Circle, the front joint corner of Lots 19 and 20; thence with the joint line of said lots S. 55-42 W. 197.3 feet to a point in the center of a branch; thence with the center of said branch as the line S. 41-27 E. 70.4 feet to a point corner of lot No. 18; thence with the line of said lot N. 55-42 E. 187.9 feet to an iron pin on the southwest side of Woodmont Circle; thence with the southwest side of said Woodmont Circle N. 34-18 W. 70 feet to the beginning corner.

This is a portion of the property conveyed to grantor by James P. Moore and Otis P. Moore by deed dated June 24, 1955 recorded in volume 529 page 9 of the R. M. C. Office for Greenville County.

This conveyance is made subject to the building restrictions applicable to Brookforest recorded in book 476 page 153.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

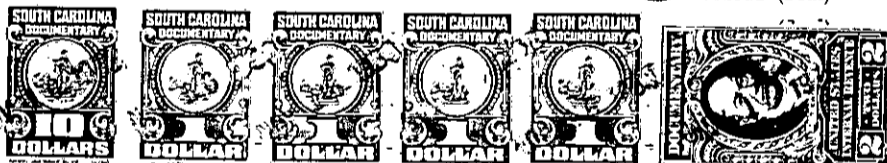
