to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WOODROW HUNT; His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 25 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Woodbriar Court at the joint front corner of Lots 24 and 25 and running thence S 50-35 E 178.4 feet to a point at the joint rear corner of Lots 24 and 25; thence S 31-02 W 74.5 feet to a point on the Northeastern side of Indigo Street at the joint rear corner of Lots 25 and 11; thence with the Northeastern side of Indigo Street N 51-32 W 174.5 feet to a point; thence following the curvature of the Northeastern intersection of Indigo Street with Woodbriar Court (the chord of which is N 06-04 W 21 feet) to a point; thence with the Southeastern side of Woodbriar Court N 39-25 E 62 feet to the point of beginning.
