Hudson, dated May 24, 1905, and recorded in the R.M.C. Office for Greenville County in Plat Book A at page 108, and having according to said plat the following metes and bounds:

BEGINNING at a point on the Northeastern side of David Street, joint corner of lot herein conveyed and property now or formerly of Dr. J. H.
