Hans H. Brand and Rudolph C. Brand, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being on the north-eastern side of Elaine Street, Greenville County, State of South Carolina and being known and designated as Lot No. 6 of subdivision of J. C. Hale as shown on plat thereof prepared by W. N. Willis, October 1953 recorded in the R. M. C. Office for Greenville County in Plat Book "CC", at Page 146 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Elaine Street, joint front corner of Lots Nos. 5 and 6 and running thence along said street S. 16-53 E. 37 feet to an iron pin; thence continuing along said street S. 34-08 E. 37 feet to an iron pin, joint front corner of Lots Nos. 6 and 7; thence along the joint side line of said lots N. 73-45 E. 165.5 feet to an iron pin; thence N. 29 W. 72 feet to an iron pin, joint rear corner of Lots Nos. 5 and 6; thence along the joint line of said lots S. 74-30 W. 160.5 feet to the point of beginning.
