All that lot of land in Greenville County, South Carolina, on Ackley Road, known as Lot No. thirty-one (31) of the Richland Land Company as shown by plat recorded in the Greenville County R. M. C. Office in Plat Book "A" at Page 315, and being the same property conveyed by J. H. Allen to Hattie Glenn by deed dated February 5, 1910 and recorded in said R. M. C. Office in Vol. 5 at Page 731.

Hattie Glenn subsequently became Hattie Sherman and died seized and possessed of the land. The grantor is one of the heirs of Hattie Sherman.
