to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Ruth C. Masters, her heirs and assigns forever:

All of that certain piece, parcel or tract of land on the Robinson Road, in Paris Mountain Township, Greenville County, State of South Carolina, being a portion of the property as shown on plat of property of Ioie H. Patton prepared by J. C. Hill, May 7, 1955 and recorded in the R. M. C. Office for Greenville County in Plat Book Y, at page 66; and being more particularly described as follows according to plat of Property of Ruth C. Masters prepared by J. C. Hill, April 1, 1957:
