That I. M. W. Fore in consideration of the sum of Two Hundred Twenty Five & 00/100 (\$225.00) in the State aforesaid, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. E. Hudson and Hazel M. Hudson, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated on Highway No. 29, just below the town of Piedmont, South Carolina, being known and designated as Lot No. 67-A of a subdivision known as Monticello Estates, as shown by a Plat thereof, by Woodward Engineering Company, dated March 1956, and recorded in the R. M. C. Office for Greenville County, in Plat Book EE, at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on West Monticello Road, at joint front corners of Lots Nos. 67 and 67-A, and running thence along the line of said lots, N. 79-30 W. 195.0 feet to iron pin; thence running with line of Saluda River, N. 10-00 E. 98.0 feet to iron pin on North Monticello Road; thence running with North Monticello Road, S. 47-06 E. 54.7 feet to iron pin; thence running, N. 76-26 E. 54.7 feet to iron pin; thence running S. 70-20 E. 89.9 feet to iron pin; thence running S. 39-55 E. 30.4 feet to iron pin on West Monticello Road; thence running with said Road, S. 10-30 W. 46.5 feet to point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

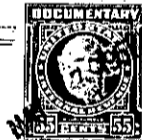
