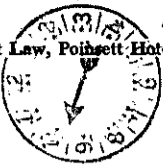

Know All Men by These Presents:

That I, Walter W. Goldsmith in the State aforesaid, in consideration of the sum of Six Hundred Ninety-five and 00/100 (\$695.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his Heirs and Assigns, forever,

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot 53 of Section B of Englewood Estates, as shown by a plat thereof dated November 1951, recorded in the R. M. C. Office for Greenville County in Plat Book "BB" at page 11, and having the following metes and bounds:

BEGINNING at an iron pin on the north side of Englewood Drive, joint front corners of lots 54 and 53 and running N. 87-30 W. 75 feet to an iron pin on the north side of Englewood Drive, joint front corners of lots 53 and 52; thence along the line of lots 53 and 52 N. 2-30 E. 150 feet to an iron pin in the line of Stepp property and at joint rear corners of lots 52 and 53; thence along the line of Stepp property and lot 53 S. 87-30 E. 75 feet to an iron pin joint rear corners of lots 53 and 54; thence along the line of lots 53 and 54 S. 2-30 W. 150 feet to an iron pin on the north side of Englewood Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any negro or person of African descent. No residence is to cost less than \$8000.00; no residence shall be erected on said lot nearer than 50 feet to the front line; no residence shall be built on lot unless said lot have 50 feet or more frontage; and no outside toilets are permitted. Sewage must be disposed of by approved septic tanks.

GRANTEE here in to pay taxes for the year 1957.

THIS DEED is conveyed subject to rights of way now in existence.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
