to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HAROLD CHILDS, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of White Horse Road, near the City of Greenville, in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 28-B, on plat of Addition to Pecan Terrace, made by Piedmont Engineering Service, June 11, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book "FF", at page 194, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwest side of White Horse Road at joint front corner of Lots 28-A and 28-B, and running thence along the line of Lot 28-A, S 51-20 W, 140 feet to an iron pin; thence N 38-40 W, 55 feet to an iron pin; thence N 87-11 W, 23.1 feet to an iron pin; thence N 51-20 E, 157.3 feet to an iron pin on the Southwest side of White Horse Road; thence along the Southwest side of White Horse Road, S 38-40 E, 70 feet to the beginning corner.

This is the same property conveyed to the Grantor herein by deed of Thomas L. Lasater, dated February 26, 1957, recorded in the RMC Office for Greenville County, S. C., in Deed Book 572, at Page 1.

AS a part of the consideration for this conveyance, the Grantee herein assumes and agrees to pay the balance on that VA mortgage in the original amount of \$7,100.00, given to the Bank of Greer on April 1, 1955, by Thomas L. Lasater, and recorded in the RMC Office for Greenville County, S. C., in Mortgage Book 632, at page 505.

Grantee to pay 1957 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

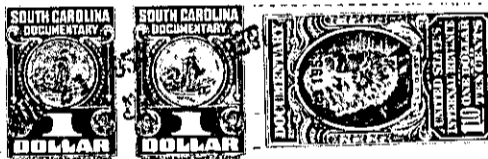
