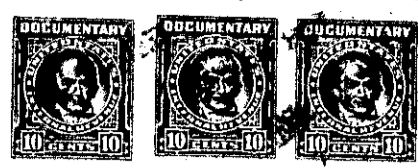

Know All Men by These Presents:

That I, Roy Brewer and Hazel Brewer, in the State aforesaid, in consideration of the sum of Nine Thousand Two Hundred Thirty-eight and 34/100 - - DOLLARS, (\$9,238.34) and the assumption of a mortgage as set out below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said I. H. Philpot, his heirs and assigns forever.

All that piece, parcel or lot of land on the White Horse Road, Paris Mountain Township, Greenville County, South Carolina, in School District 300, (formerly 10-B), and described as follows:

BEGINNING at an iron pin on the White Horse Road, and running thence with C. P. Wynn's line, S. 78 E. 21 chains to iron pin; thence N. 84 E. 9.50 chains to iron pin, corner of Tract 3; thence N. 17 W. 10.16 chains to iron pin, corner of Tracts 1, 3 and 4; thence S. 82 W. 12.60 chains to iron pin; thence N. 69 W. 13.40 chains to iron pin in White Horse Road; thence with said Road, S. 9 W. 7.60 chains to bend; thence S. 6 E. 1.82 chains to the beginning corner; containing 23 acres of land.

Said premises being the same conveyed to the Grantors herein by W. L. Hester by deed recorded in Book of Deed 459, at page 413.

The Grantee herein assumes and agrees to pay a mortgage executed by the Grantors herein in the original amount of \$9,000.00 with a present balance of \$7,761.66 to Fidelity Federal Savings and Loan Association, of Greenville, S. C.
