All that lot of land in Greenville County, South Carolina on the northern side of Jasmine Drive (formerly Douglas Street), known and designated as Lot Fifteen (15) on a plat of Grand-View made by Woodward Engineering Company, March, 1957, and recorded in Plat Book "KK" at Page 93 in the Greenville County R. M. C. Office, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin at the corner of Lot Fourteen (14) and running thence with the northern side of Jasmine Drive N. 72-35 E. 62.0 feet to the corner of Lot Sixteen (16); thence with the line of Lot 16 N. 17-25 W. 150 feet to a pin in the rear line of Lot Eighteen (18); thence with the rear line of Lots Eighteen and Nineteen (18 & 19) S. 72-35 W. 62.0 feet to a pin at the corner of Lot Fourteen (14); thence with the line of Lot Fourteen (14) S. 17-25 E. 150 feet to the beginning corner.
