All those pieces, parcels or lots of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the southern side of North Wingate Road and being known and designated as Lots Nos. 7 and 8 of Pecan Terrace, Section 2 as shown on plat thereof prepared by Piedmont Engineering Service dated November, 1955 and recorded in the R.
