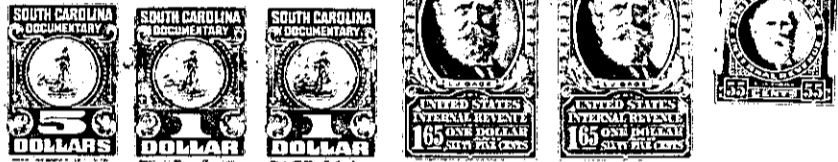
All that certain piece, parcel or lot of land lying and being on the southerly side of Timberlake Drive, near the City of Greenville, S. C., being shown as Lot No. 36 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Timberlake Drive, joint front corner of Lots 35 and 36, and running thence along the common line of said lots S 7-04 W 148.9 feet to an iron pin, joint corner of lots 35, 36 and 37; thence along the common line of lots 36 and 37 S 82-57 E 160 feet to an iron pin on the westerly side of Timberlake Drive; thence along said Drive N 7-40 E 89.9 feet to a monument; thence continuing along said Drive on a curve, the chord of which is N 37-20 W 84.6 feet to an iron pin; thence continuing with said Drive N 82-20 W 60 feet to an iron pin; thence continuing with said Drive N 85-54 W 42 feet to an iron pin, the point of beginning.
