Know All Men by These Presents:

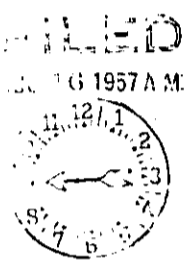
That We, E. D. Kellett and Macie D. Terrell, in the State aforesaid,

All that certain street or roadway in Greenville County, South Carolina, lying near Woodruff Road and having the following metes and bounds, to-wit:

BEGINNING at a nail in the center of Rocky Slope Road within the boundary of property belonging to L. D. Kellett and running thence S. 63-41 W. 1,095.8 feet to an iron pin on the line of Jones property; thence along that line, N. 27-20 W. 50 feet to an iron pin; thence within the boundary of Macie D. Terrell property, N. 63-41 E. 1,039.3 feet to a nail in the center of Rocky Slope Road; thence along the center of said road, S. 35-13 E. 39.8 feet to a nail at an angle in said road; thence still along center of said road, S. 33-29 E. 10.8 feet to a nail at the beginning corner.

The above conveyance is made to Greenville County for street or road purposes only and the property conveyed is made up of two strips from each of the grantors and is shown on a plat made by Woodward Engineering Co., in May, 1957.
