to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Huguenin & Douglas Inc., its successors and assigns

All that piece parcel and lot of land lying and being in Gantt Township, County of Greenville, State of South Carolina, near the City of Greenville, lying and being in that certain subdivision known as "Belle Meade", being owned by Derby Heights Inc. shown as Lot No. 182 according to a plat made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book EE, Pages 116-117 and being more particularly described as follows:

BEGINNING at an iron pin on the west side of West Dorchester Boulevard at the joint front corner of Lots 181 and 182 and running along the line of Lot 181 S. 54-55 W. 150 feet to an iron pin, joint rear corner of Lots 181 and 182; thence N. 35-05 W. 70 feet to an iron pin, joint rear corner of Lots 182 and 183; thence N. 54-55 E. 150 feet to an iron pin on West Dorchester Boulevard, joint front corner of Lots 182 and 183; thence along West Dorchester Boulevard S. 35-05 E. 70 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 505, at Page 73, as amended in Deed Book 521, Page 199.

The grantor is to pay 1957 taxes.
