Know All Men by these Presents:

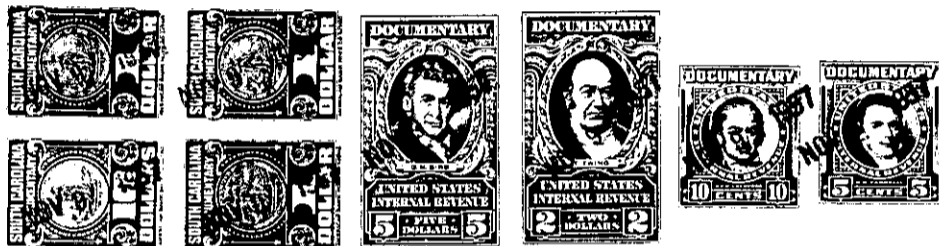
That I, R. W. Manley in the State aforesaid, in consideration of the sum of Sixty-Five Hundred and No/100 (\$6500.00) DOLLARS,

Manley, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being shown as lot # 90, on plat of property of City View Annex, recorded in Plat Book G at Page 155, in the R.M.C. Office for Greenville County, and being more particularly described as follows:

BEGINNING at a stake on the Northern side of Agnew Road (sometimes called View Point Drive), at corner of lot # 89, and running thence with the line of said lot, N. 53-40 E. 318 feet to an iron pin in branch; thence in an Easterly direction with the branch 115 feet to an iron pin, joint rear corner of lots 90 and 91; thence with the line of lot # 91, S. 53-40 W. 377 feet to an iron pin on Agnew Road; thence with Agnew Road, N. 49-20 W. 80 feet to the point of beginning.
