to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. A. Cannon, Jr., his heirs and assigns:

All that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, being designated as Lot. No. 19 of a subdivision of the Property of Blue Mountain Development Company, known as "Blue Mountain Park", the same as shown on a plat thereof prepared by James M. Beeson, March 15, 1955, said plat being recorded in the R. M. C. Office for Greenville Counth, South Carolina, in Plat Book "EE", page 121, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of East Sable Court, joint front corner Lots 19 and 20, and running thence N. 60-30 E. 160 feet to an iron pin, joint rear corner Lots 19 and 20; thence S. 29-30 E. 101.4 feet to an iron pin, joint rear corner Lots 18 and 19; thence S. 60-30 W. 160 feet to an iron pin on East Sable Court; joint front corner Lots 18 and 19; thence along East Sable Court N. 29-30 W. 101.4 feet to an iron pin, the point of beginning.
