William M. Willis, Jr., his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the southeastern side of Pine Creek Drive and being known and designated as Lot No. 320 of Belle Meade, Section 3 as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 187, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Pine Creek Drive joint front corner of Lots Nos. 319 and 320, and running thence along said Drive N. 32-08 E. 81 feet to an iron pin joint front corner of Lots Nos. 320 and 321; thence along the joint line of said lots S. 57-52 E. 130 feet to an iron pin; thence S. 32-08 W. 81 feet to an iron pin; thence N. 57-52 W. 130 feet to the point of beginning.
